
Dear District Attorney Conley:

Re: Claim of Sexual Abuse of a Minor by Brother Robert Burgess and another.

Dear Cardinal Law:

This office has been retained to represent [redacted] of Westwood, MA, [redacted], who alleges that he was a victim of sexual abuse by two members of the Salesian Order, a Brother Dennis [redacted] in New Hampshire, and a Brother Robert Burgess at a rectory in South Boston.

[redacted] alleges that when he was seven years old in or about 1970, he won a free week trip to the Don Bosco Camp in New Hampshire. During the week, Brother Dennis came into his room and sexually abused him by touching his genitals.

At the end of the week, his parents came to pick him up and paid for him to stay another week. Brother Burgess told [redacted] parents that he lived at a rectory in South Boston and would drive their son back from New Hampshire the next week. Brother Burgess took [redacted] to his room at the rectory and had the child perform a sexual act on him. At Christmas time, Burgess visited the [redacted] home with a gift and offered to take [redacted] to a Christmas party. Instead he took the child again to his room at the rectory and performed a sexual act on the child.

[redacted] recalled his own sexual abuse at the hands of a priest when news articles about the Goeghan case were reported last month. He informed his mother at that time. He has never revealed the abuse to anyone.


[redacted] alleges that on a re-awakening of the abuse by Burgess, he realized that the abuse had caused him permanent psychological damages that have affected his relationships with others,
