Safe environment training for adult employees and volunteers who have contact with minors is a key element of the U.S. Bishops' Charter for the Protection of Children and Young People. The Diocese of Peoria has recently unveiled a new training program for adults. The new program, available at <a href="https://peoria.cmgconnect.org">https://peoria.cmgconnect.org</a>, is designed to help adults know what to look for in children that might indicate that they are victims of abuse and what behavior to look for in adults that might indicate abusive behavior with children. The program also covers diocesan safe environment policies, standards of conduct, and how to report suspected abuse or neglect. Completion of the training program is

required for all personnel (employees and volunteers) of the parishes, schools, and agencies of the Diocese of Peoria who have contact with minors.

### "CATHOLIC DIOCESE OF PEORIA REQUIRES PRIEST TO NO LONGER FUNCTION IN PUBLIC MINISTRY"

Bishop Daniel R. Jenky, C.S.C. of the Catholic Diocese of Peoria has, upon the unanimous advise of the Diocesan Review Commission, required Father Terry Cassidy, Pastor of St. Ann Church, Peoria, Illinois, to step down from public ministry. Allegations of sexual misconduct with a minor were made against Cassidy dating back nearly thirty years ago. He can no longer function as a Catholic priest in any public capacity, wear clerical garb or the Roman collar, and is to refrain from using the title Reverend or Father.

Cassidy's assignments serving in the Diocese of Peoria include: Christ the King Church, Moline (1984-1987); St. Catherine Church, Aledo, St. Mary Church, Keithsburg, St. Anthony Church, Matherville, St. Theresa Church, New Boston, St. John Church, Viola, St. Andrew Church, Oquawka (1987-1989); St. Mark Church, Peoria (1989-1990); St. Edward Church, Chillicothe (1990-1992); St. Mary Church, Moline (1992); St. Jude Church, Peoria (1992-1994); St. Mary Church, Wenona, St. John the Baptist Church, Lostant (1994-1995); St. Joseph Church, Chenoa, St. Mary Church, Lexington (1995-1999); St. Martin de Porres, Peoria (1999-2001); Spiritual Advisor for TEC (2006 – 2013); Spiritual Advisor for Cursillo (2006 – current); St. Ann Church, Peoria (1999-current).

Under the direction of Bishop Jenky, the Catholic Diocese of Peoria remains committed to maintaining a safe environment for all children. The implementation of the Protecting God's Children program and the current safe environment program used within the Diocese, has made an important impact on the safety of the children in the Catholic faith communities throughout the 26 counties of the diocese.

Bishop Jenky continues to pray daily for all victims of sexual abuse and apologizes and prays that the Lord will heal the wounds resulting from this abuse. Bishop Jenky asks for the prayers of the faithful for all the individuals involved in this case and especially for the overwhelming majority of our priests and lay ministers whose zeal and holiness do so much to build up the body of Christ in Central Illinois.

At this time, out of respect for the privacy of the individuals involved in the case, the Catholic Diocese of Peoria will not be providing any further information.

#### "Catholic Diocese of Peoria Removes Three Retired Priests from Public Ministry"

Bishop Daniel R. Jenky, C.S.C., of the Catholic Diocese of Peoria, upon the unanimous advice of the Diocesan Review Commission, has required these three retired priests to step down from public ministry due to each having credible allegations of sexual abuse of a minor:

Fr. George Hiland

Fr. Duane Leclercq

Fr. John Onderko

Hiland is alleged to have engaged in sexual misconduct with a minor approximately fifty year ago.

Leclercq has been alleged to have engaged in sexual misconduct with a minor approximately thirty years ago.

Onderko has been alleged to have engaged in sexual misconduct with a minor approximately fifty-five years ago.

Effective immediately, Hiland, Leclercq and Onderko can no longer function as Catholic priests in any public capacity, wear clerical garb or the Roman collar, and are to refrain from using the title Reverend or Father.

It is the policy of the Diocese to report all allegations of child sexual abuse to the proper State's Attorney. Accordingly, these allegations have been reported to the proper State's Attorneys.

George Hiland's assignments while serving in the Diocese of Peoria included: St. Stephen, Streator (1958-1971), St. Patrick, Arlington (1971-1976), St. John the Baptist, Fairbury and St. James, Forrest (1976-1992), St. Patrick, Dwight (1992-1994), Senior Status (1994).

### "DISMISSAL FROM CLERICAL STATE CONFIRMED IN THE CASE OF THOMAS MILLER"

#### For Immediate Release

**PEORIA-** The Diocese of Peoria has been informed that the Congregation for the Doctrine of the Faith has rejected the appeal of Thomas Miller in regard to his dismissal from the clerical state. Thomas Miller was dismissed from the clerical state October 2006, but appealed this decision. Recently, the Diocese of Peoria was informed that the Congregation for the Doctrine of the Faith has upheld the initial decision and that he is now permanently dismissed from the clerical state. The Congregation also indicated that no further appeal is possible. The Congregation duly considered all evidence presented by both parties in this matter and affirmed his permanent dismissal.

Thomas Miller has served at Holy Trinity Parish, Bloomington, Schlarman High School, Danville, and St. Bernard Parish and St. Vincent de Paul Parish, both located in Peoria. Bishop Daniel Jenky has asked for the prayers of the faithful for all the individuals involved in this case and especially for the overwhelming majority of our priests, religious and laity throughout the Diocese whose zeal and holiness do so much to build up the body of Christ in central Illinois.

No further comment will be issued regarding this matter.

Hiland is alleged to have engaged in sexual misconduct with a minor approximately fifty year ago.

Leclercq has been alleged to have engaged in sexual misconduct with a minor approximately thirty years ago.

Onderko has been alleged to have engaged in sexual misconduct with a minor approximately fifty-five years ago.

Effective immediately, Hiland, Leclercq and Onderko can no longer function as Catholic priests in any public capacity, wear clerical garb or the Roman collar, and are to refrain from using the title Reverend or Father.

It is the policy of the Diocese to report all allegations of child sexual abuse to the proper State's Attorney. Accordingly, these allegations have been reported to the proper State's Attorneys.

The current Review Commission is made up of clergy, physicians, educators, psychologists, a victim, attorneys, and civil officials.

The Diocese of Peoria was not aware of any allegations at the time of his incardination into the Diocese of Peoria in 1993.
