#### **Ernesto Garcia CSsR**

Redemptorist priest from the Philippines. Ordained 1981 as a Redemptorist priest. 1995 CONVICTED on charge related to sex abuse of a 13-year-old boy in Barrhead, Alberta (Diocese of St. Paul, Alberta). Sentenced by Justice E.A. Hutchinson to 90 days to be served on weekends "in a place not as harsh or brutal as a provincial jail or federal institution." Father Garci is now active, and has been for several years, as a Redemptorist priest in the Archdiocese of Lipa, Philippines (Lipa City, Batanga, Philippines)

## Priest gets 90 days for sex abuse

A Roman Catholic priest was sentenced to 90 days in jail Wednesday for molesting an altar boy who turned to him for emotional support after his parents' separation.

Ernie Garcia, 49, a priest with the Order of the Redemptorists, was convicted of sexual interference for sexually touching the 13-year-old.

"It gave me no pleasure, no joy, no satisfaction whatsoever in finding the accused guilty of this offence," Court of Queen's Bench Justice E.A. Hutchinson said.

"He slipped, probably due to human failing, an aberration. He now faces the penalty.

"The fact that there are so many letters in support of the accused illustrates the fact that he holds an important position in society."

A two-inch thick pile of letters was supplied to the judge.

Garcia is to serve the sentence intermittently. He had no prior record.

Garcia's religious supervisor within the Order of the Redemptorists, Bill Bernard, released a written statement after Hutchinson convicted Garcia.

"We, his Redemptorist colleagues, are saddened by this decision. We respect the decision of the court, but we remember that Father Garcia retains the right of appeal." The statement also said that the order was concerned about the teen and his family, and offered its support to them.

Garcia has not been allowed to minister since the allegations were made. His suspension still stands. It would only be lifted if the conviction was overturned on appeal.

The sexual touching took place at the teen's home. The teen saw Garcia as a trusted friend and was happy to see him one morning last year when he came to his house when he was home alone. Garcia asked the teen about his father, who'd left the family. This made the teen cry. Garcia got the 100-pound, five-foot-three-inch tall teen to sit on his lap. Garcia asked him if he was a man yet, and felt his nipples under his shirt. He asked him if he was circumcised, and the teen said no. Then Garcia rubbed his penis over his clothes.

"These events did happen," the judge said. And they "were not done for the purpose of a medical exam ... or to assist the complainant in understanding the need for circumcision."

The judge commended the youth's poise as he stood up to a rigorous cross examination by the defence. Lawyer Peter Royal had argued that the teen's testimony couldn't be relied upon. He noted the teen couldn't say exactly how long the priest rubbed his penis. Hutchinson commented: "Under such circumstances time could literally have stood still."

Does a Canadian Pardon erase convictions?

A pardon do not erase convictions. It does not allow a person to say that they do not have a criminal record. The correct response is: "Yes, I have been convicted of a criminal offence for which I have received a pardon."

and

When asked if I have a criminal record after obtaining a pardon, what should I say? You cannot deny the fact that you were once convicted of an offence. However, you may choose to disclose that you have obtained a pardon, which is proof you are a law-abiding citizen. The correct response would be: "Yes, I have been convicted of a criminal offence which I have received a pardon.

and

Is it true that changes have been made to the Criminal Records Act concerning pardons in Canada for sex offenders?

There have been no changes that effect how or whether sex offenders will be granted or denied a pardon in Canada. There were, however, some changes to the legislation that became law in August 2000, which may affect sex offenders who have already been granted a pardon. These new changes enhance the capacity of police forces to explore the criminal background of those who wish to work with children. This includes a review of criminal records for designated sex

offences where a pardon has been granted. By placing a 'flag' on the records of sex offenders in the Canadian Police Information Centre, police can be alerted that a pardoned record exists so they can request the Solicitor General's authorization consent in writing. A person or organization that obtains information under this section in relation to an application for a position shall not use it or communicate it except in relation to the assessment of the application.

and

Are Canadian pardons recognized outside Canada?

No. Many foreign countries, including the United States (U. S.), do not recognize a Canadian pardon. If you have a criminal record and are interested in going to the U.S., you may want to apply for an "American Immigration and Naturalization Service waiver" (American INS waiver).

This procedure may entail disclosure of your Canadian pardoned criminal record for review by U.S. Immigration and Naturalization officials. An American INS waiver package can be obtained at the U.S. Embassy in Ottawa or at any U.S. Consulate or port of entry.

All of that aside, my question is: Why is Father Garcia still in the priesthood? Why was he not defrocked?

Perhaps those of you interested in pardons could spend a little effort sorting out why this man is still a priest?
